

Partial Scope Agreement with Colombia AAP.C no. 28

Partial Scope Agreement on Trade Matters AAP.C no. 28 between the Bolivarian Republic of Venezuela and the Republic of Colombia. The text of "Decision 001 of the Administrative Commission of the Partial Scope Agreement on Trade Matters no. 28 (AAP.C no. 28), entered into between the Bolivarian Republic of Venezuela and the Republic of Colombia, First Additional Protocol" was published on May 26, 2023 in Official Gazette no. 42.637

Relevant aspects

- The Partial Scope Agreement on trade matters was signed on November 28, 2011 by the presidents of Colombia and Venezuela.
- Consideration is given to the inclusion and exclusion of products and the modification of preferential levels granted (Annex I) in Appendixes A an B of the agreement.

- It is stated that unmodified items remain as established in Annex I of AAP.C no.28.
- An introduction note is included, and specific origin requirements negotiated in the agreement are mentioned (Appendix I, Annex II).
- The parties agree to formally register the referred-to Decision 001 with the General Secretariat of ALADI.
- Based on modifications agreed, ALADI's
 General Secretariat will be requested to
 modify Appendix A and Appendix B of Annex
 I on Preferential Duty Treatment, as well as
 Appendix I on Specific Origin Requirements of
 Annex II on Origin Regime.

- This agreement was entered into on February 16, 2023.
- The decision-protocol will be effective as from the date of the last of communications whereby the parties are informed in writing of the execution of related procedures in accordance with their internal legislation.
